

Introduction

Presque Isle Township has an abundance of natural resources, which offer recreational opportunities to residents and visitors. The township recognizes the importance of recreational planning and works with volunteers and public and private agencies to complete projects. In conjunction with the township's facilities, the county, state, and privately-owned recreational facilities provide the area with a wide variety of recreational activities and programs.

In 2016, Presque Isle Township worked with McKenna Associates to prepare a recreation plan. Recreation plans that have been approved by the Michigan Department of Natural Resources allow the Township to be eligible for State of Michigan recreational grant funding. In December 2022, Presque Isle Township contracted with

Regional Location & Topography




Figure 1-1 Location Map

Presque Isle Township covers approximately 47.2 square miles in the southeastern section of Presque Isle County within Michigan's Northeastern Lower Peninsula. About 35.6 square miles of the township is land area (22,784 acres) and about 11.6 square miles is water. The township is triangular in shape and is bordered by Lake Huron to the north and east, Alpena County to the south, and Krakow Township to the west (**Figure 1-1**).

The township is not close to Michigan's large urban areas. It takes a little over four hours to

the Northeast Michigan Council of Governments (NEMCOG) to update its recreation plan. This recreation plan was prepared for Presque Isle Township-owned, leased, and operated recreational facilities and programs.

The intent of the Presque Isle Township Recreation Plan is to:

- Maintain and improve the current recreation-related facilities and services
- Enable Presque Isle Township to apply for and obtain available funding
- Assist with implementation of projects
- Improve accessibility to facilities and activities through compliance with the Americans with Disabilities Act (ADA) and Universal Design Standards

drive to Detroit and Lansing, and about three hours to drive to the Bay City/Saginaw region. However, the township is close to the recreation and resort areas in Northern Michigan, Mackinaw City and the Straits, Petoskey, Harbor Springs, Gaylord, Indian River, and Cheboygan.

Presque Isle Township is relatively flat due to glaciation and inundation by glacial Lake Huron. The township is approximately 580 feet above sea level, while it is about 660 feet above sea level near the Lake Huron shoreline.

A Brief History of Tourism & Recreation in Presque Isle Township

Tourism and recreation have been a significant part of Presque Isle Township's history beginning with the Native Americans and pioneers who were drawn to the township's woodlands, wetlands, water, and wildlife.

First, the Old and New Presque Isle Lighthouses are renowned tourist attractions. In 1840, the Old Presque Isle Lighthouse was built, and the harbor light operated until 1871. The Old Presque Isle Lighthouse Park features two main structures, a keeper dwelling, and a light tower.

Next, the Fireside Inn and Presque Isle Lodge are some of the first known establishments that sparked recreational tourism in the township. The Fireside Inn was constructed in 1908 and began receiving steady guests by mid-July 1909. The Presque Isle Lodge was built in 1920 and was the fourth largest resort/hotel in the area.

Third, Rockport State Park is one of Michigan's most unique state parks, which encompasses 4,237 acres in Presque Isle and Alpena Counties.

Within Presque Isle Township, the state park is designated as a Dark Sky Preserve, and contains hiking trails, sinkholes, fossils, beaches, a historic ghost village, and shipwrecks. Historically, Rockport State Park operated as a quarry from 1914 until the end of the 1950's. The loading dock foundations used to load the freighters with stone still stretch into Lake Huron.

More recently, the US 23 Heritage Route was established under the Michigan legislature in The US 23 Heritage Route is a Pure Michigan Byway, which begins in Standish and travels 200 miles up the Lake Huron shoreline to Mackinaw City. The route offers scenic views as well as sites of historical, recreational, and cultural significance. Furthermore, the township has six designated Michigan Historical Markers: Range Liaht. Old Lighthouse. New Lighthouse. Burnham's Landing, Kauffman House, and Presque Isle Lodge. Public lands also provide green spaces within the township.

In addition, the Thunder Bay National Marine Sanctuary protects nearly 100 historic shipwrecks in Lake Huron. The sanctuary has impacted Presque Isle Township since 2014 through

signage, buoy markers over shipwrecks, providing publicity for the lighthouses, and offering glass bottom boat tours.

Population, Housing, & Transportation

According to the 2021 American Community Survey, Presque Isle Township has a population of 1,743 people. There are 1,698 total housing units with 828 classified as occupied and 870 classified as vacant. Out of the vacant housing units, 799 are classified as seasonal, recreational, or occasional use. Based on the township's average household size of owner-occupied units of 2.13, the estimated seasonal population would

be approximately 1,702 persons. However, this estimate does not include persons who stay at private lodging places, campgrounds, or at homes with family or friends, which makes it difficult to obtain a seasonal population estimate. U.S. 23 travels through the center of the township to connect residents to Alpena, Cheboygan, and Gaylord.

Geology & Soils

Presque Isle Township's bedrock consists of a thin line of bell shale through the center of the township with dundee limestone to the north and traverse group to the south.

The township has two soil types: Summerville-Alpena-Ruse Association and Carbondale-Lupton-Tawas-Roscommon Association. The Summerville-Alpena-Ruse Association is found in larger concentrations throughout the township and predominantly consists of nearly level to undulating loamy soils that range from welldrained to very poorly drained. Generally, these soils are suitable for recreational activity with only slight to moderate soil limitations. Carbondale-Lupton-Tawas-Roscommon Association is found in smaller concentrations in the township, particularly in the southern sections. These soils are predominantly organic, wet most of the year, and are found in drainage channels, marshes, and swamps. Recreational activity is severe to very severely limited on this soil type.

Karst features can be found in Rockport State Park (Figure 1-2). Karst topography is characterized by sinkholes, underground streams, and caves. These features occur when the limestone bedrock gradually dissolves and the surface rock collapses into the cavity, which causes tremors that may be reported as earthquakes. It takes several decades for new sinkholes to appear on the surface. Due to the moist terrain within the bedrock and the partially subterranean shaded location, the sinkholes host plant communities that are not found in the surrounding surface areas. In addition, karst features have a direct connection to the groundwater and put the township's groundwater at risk for contamination due to illicit dumping.

Additionally, all of Presque Isle County's drinking water is from groundwater that is provided through subsurface aquifers. These aquifers are highly vulnerable to surface contamination from septic systems, abandoned wells, barnyards, feedlots, pastures, croplands, and road corridors.

Surface Water

Presque Isle Township is part of the Ocqueoc River Watershed and Lake Huron Coastal Watershed. The Lake Huron Coastal Watershed occurs along the northern and eastern coasts of the township.

Lake Huron is the largest surface water resource in Presque Isle Township. It is the second largest of the five Great Lakes in surface area (23,000 square miles) and has the greatest length of shoreline at 3,827 miles due to its many islands and inlets. Over the last century, Lake Huron's fishery has undergone significant shifts due to aquatic invasive species, such as sea lamprey, zebra mussels, guagga mussels, round goby, and alewives.

Upland & Lowland Woodlands

Woodlands provide wildlife habitat and hunting opportunities, prevent erosion, and act as a noise buffer. In Presque Isle Township, woodlands account for over 13,000 acres with upland forests covering 6,641 acres and lowland forests covering about 6,704 acres. The township's upland forest types include aspen/birch stands, pine (red, jack, and white), oak (red and white),

In addition, Grand Lake and Long Lake are predominant water resources in the township. Approximately two-thirds of Grand Lake is located within the township with the remaining one-third located in Krakow Township. The lake is 5,874 acres in size and encompasses 19 islands. It has a maximum depth of 25 feet and is about eight miles long. Conversely, the northern half of Long Lake is located in Presque Isle and Krakow Townships, and the southern half is located in Alpena County. Long Lake has a surface area of 5,652 acres and is approximately 7.8 miles in length with a maximum depth of 25 feet. Presque Isle Township also has numerous smaller water resources, such as Lake Esau and the Bell River.



Administration

Presque Isle Township is governed by a fivemember elected Board of Trustees consisting of a supervisor, clerk, treasurer, and two trustees (**Figure 2-1**). The Township employs an Administrative Assistant and a part-time facility manager to maintain the township parks and facilities. In 1995, the Board of Trustees created a Parks and Recreation Advisory Committee; however, the committee lacked the authority to operate the township parks system or administer the community resources. In 2009, the township reorganized the administration of the park system by creating a six member Parks and Recreation Committee.

ADMINISTRATIVE STRUCTURE

Parks & Recreation Funding

The Township Treasurer, the liaison to the Parks and Recreation Committee, develops the annual parks and recreation budget (**Table 2-1**). Much of the revenue for maintenance and improvements comes from the general fund, restricted general fund for parks and recreation, Community Foundation for Northeast Michigan, and the tower climb admission fee and gift shop

sales from both the New and Old Lighthouses. The revenue from the tower climb fees and the gift shop sales goes toward maintaining Old and New Lighthouse Parks. The Township Board can accept grants and purchase land for recreational purposes. The Parks and Recreation Committee votes on event allocation funding only.

Recreation Grant History

Presque Isle Township received and successfully completed three grants through the Michigan Department of Natural Resources recreation grants program.

- 1. **Old Presque Isle Lighthouse**, **1993, Grant # TF93-018**: Acquisition of approximately 28 acres, including 1,000 feet of Lake Huron shoreline.
- 2. **Old Presque Isle Lighthouse Park, 1996, Grant # TF96-029:** Develop 21 acres including 1,630 feet of Lake Huron frontage for water access and general park purposes, including road and parking, trails, visitor center renovations, and site improvements.
- 3. Range Light Park Development, 2012, Grant # 26-01723: Development to include disability access via a 300-foot boardwalk to a raised and covered pavilion in Range Light Park.

Inventory Method & Classification System

Presque Isle Township contains a great variety of natural resources including Lake Huron, inland lakes, rivers/streams, and many different types of recreation areas. Staff from the Northeast Michigan Council of Governments (NEMCOG) visited each recreation facility to do an on-site assessment in order to update the park's information, accessibility rating, and photos from previous years. In addition, information from state and local government agencies, volunteer groups, and local Chambers of Commerce was used to update the plan's information.

An evaluation of each park's accessibility was completed during the onsite inventory. This assessment visually evaluated the accessibility of facilities and routes to facilities for persons with mobility constraints. Barrier-free accessibility in parks and recreational facilities is important for current and future programming as it makes these spaces more inclusive and easier for all to use. The assessment followed the Michigan Department of Natural Resources' scale for evaluating park accessibility in the 2021 Guidelines for the Development of Community Park, Recreation, Open Space, and Greenways Plans on a scale of 1 to 5.

Description

New Lighthouse Park is located approximately one mile north of the Old Presque Isle Lighthouse. Ownership of the property was officially transferred from the Bureau of Land Management to Presque Isle Township during a ceremony on June 16, 1998. The Federal Government operates and maintains the lighthouse's active navigational aid and its associated electronic and lighthouse equipment. The New Presque Isle Lighthouse has been listed on the National Register of Historic Places since 1983 and a State Historical Marker was dedicated on July 6, 1991 (Site NO. L1562).

The lighthouse is the tallest on Lake Huron and is generally considered to be one of the most picturesque out of the surviving Great Lakes lighthouses. The tower may be climbed for a fee when the gift shop is open. The grounds contain a picnic pavilion at the tip of the scenic point. The former garage has been renamed Garrity Hall and has been renovated to include heat, a kitchen, and a meeting room. Portions of the property near the Presque Isle State Harbor have non-motorized trails.

The New Lighthouse was built in 1870, and its conical tower stands 113 feet high, which produces a focal plane of 123 feet above the mean low water level of Lake Huron. Adjoining the tower and connected to it by an enclosed walkway is the original brick and gable-roofed Keeper's House. The base is surmounted by a round iron watch room and a ten-sided cast





iron lantern. The light was first turned on at the beginning of the 1871 navigation season and was automated by the Coast Guard in 1970. The Coast Guard removed the original lens, a Third-Order Fresnel manufactured by Henry LaPaute of Paris, in May 2003 and it is on display in the annex to the 1870 Keeper's The Federal Government retains Cottage. ownership of the lens. In 1988, the tower was re-bricked and restored to its original condition. The 1905 house was erected as a more spacious residence for the keeper and his family, and is used as a museum that the Presque Isle Township Museum Society operates.

In 2001, a major restoration project was completed to restore and preserve the Keeper's House with the assistance from a CMI Grant. The Township matched 25% of the grant to fund the \$246,123 grant project. In 2003, the Township was awarded a Clean Michigan Initiative (CMI) Waterfront Redevelopment Grant for \$91,500 to renovate the lens and reconstruct the lantern room. In 2018, Presque Isle Township Museum Society to establish the





Presque Isle Township Lighthouses Restoration Fund at the Community Foundation for Northeast Michigan.

In 2022, lighthouse restoration funds, lighthouse gift shop funds, Township recreation committee funds, and Township facility budget funds were used to replace cracked bricks and repair window lintels.

Description

The Old Lighthouse Park is located east of Presque Isle Harbor. The site has been on the National Register of Historic Places since 1973 (Ref. NO. 72000957), and a State Historical Marker was erected and formally dedicated on June 19, 1965 (Site No. P24577). In 1995, the site was transferred from the Stebbins Family to Presque Isle Township with assistance from the Michigan Natural Resources Trust Fund Program and private donors.



The park provides trails and picnic areas. Visitors may ring a bell, access the museums, and tour the Keeper's Cottage. Admission is charged to climb the lighthouse tower.

In the 1830's, ships engaging in coastal trade used Presque Isle Harbor for shelter and as a loading/unloading dock for cordwood used in their boilers and to get clean drinking water. prompted the Federal Government to appropriate \$5,000 for a lighthouse at the harbor entrance. Materials were brought by boat and Jeremiah Moors of Detroit constructed the lighthouse with a conical tower of 30 feet tall, 18 feet in diameter at the base, and nine feet at the top. The tower walls are four feet thick and blocks of stone were carved to form the circular stairway to the top. Equipment for the lighting was furnished by John Scott, who certified the lighthouse and dwelling on September 7, 1840. Upon its completion, Henry L. Woolsey was appointed its first keeper, and the light was manned until 1871.

Description

The park is located on both sides of Grand Lake Road consisting of a public beach, swings, and picnic pavilion. In 1870, Presque Isle Range Lights were constructed to mark the channel into Presque Isle Harbor and guide recreational watercraft into the harbor/marina. The original forward-range light was restored and returned to the site in 2003 and 2004, but has not been open to the public. A boardwalk and picnic pavilion were constructed with the aid of a grant from the Michigan Department of Natural Resources and officially opened in 2015.

Description

Presque Isle Township partnered with the Presque Isle County Road Commission to receive a Transportation Enhancment Grant in the amount of \$127,193. The grant was used to pave six foot shoulders on both sides of a 2.83 mile portion of the trail system from Whiskey Point Road to the

Kauffman House. Construction was completed in May 2004 for a total cost of \$265,789. Matching funds were contributed by the township, corporate sponsors, local organizations, citizen donors, and fundraisers.

Description

On April 5, 1960, Russell and Mildred Kauffman dedicated approximately 0.8 acres with the intent the land be developed as a Presque Isle Township park. The property remains undeveloped except for a launch site to Lake Esau.

Other Public Recreation Facilities

Spitler Shore Nature Sanctuary

Location: Kauffman Road (west of South Albany Point)

Description

In December 2017, the Michigan Nature Association acquired the nature sanctuary along the shore of Lake Huron's 'Shipwreck Alley.' The site consists of approximately 51 acres and is primarily composed of aspen, cedar, and balsam fir. Red pine, red oak, and birch are also found at this site. The sanctuary was donated by Gerald Spitler, who desired the property remain open to the public and

be conserved in its natural state with a trail system. The Lake Huron bottomlands immediately offshore, including those areas adjacent to the sanctuary, are part of the 4,300 square mile Thunder Bay National Marine Sanctuary, which protects one of America's best preserved and nationally significant shipwreck collections. The wreck of the *Albany* is in the bay offshore of the nature sanctuary.

Emily Hunt Nature Preserve

Location: Shubert Hwy. (two miles west of US-23)

Description

The Emily Hunt Nature Preserve is managed by Huron Pines. This preserve offers opportunities for the public to learn about stewardship, best practices, and land management. There is a small

parking lot at the trailhead. In March 2019, the Thunder Bay Audubon Society donated 428 acres to Huron Pines.

Presque Isle State Harbor

Description

The Presque Isle State Harbor is clean marina certified and provides 120 slips (45 seasonal, 75 transient). It is one of the last state harbors for fuel until Mackinaw City and includes a boat

launch and day use dockage, restrooms, showers, grills, a dog run, a fishing pier, and a swimming beach.

Besser Natural Area

Description

The Michigan Department of Natural Resources maintains this 134-acre tract in the southeastern portion of Presque Isle Township along more than 4,000 feet of Lake Huron shoreline at False Presque Isle Harbor. The site is the location of the Village of Bell, an abandoned lumbering era village. The Bell Cemetery was restored and re-dedicated in 1989.

A stand of virgin pine on the site is maintained as a memorial to the lumbermen who spared the trees. The site also has a one-mile hiking trail to a small lagoon. A large freestanding chimney, which was previously attached to the Kamp Kairphree lodge for girls and women aged 8 to 18 (1922-1927) can be viewed from the trail.

Rockport State Recreation Area

Description

This 4,237-acre recreation area is located in the southeast corner of Presque Isle Township as well as in Alpena Township, Alpena County. The Besser Natural Area is located in Rockport State Recreation

Area. The park houses unique sinkholes, a deep water protected harbor, a 300-acre old limestone quarry, a boat launch, a picnic area, and an outhouse.

Thunder Bay National Marine Sanctuary

Description

Designated in 2000, Thunder Bay National Marine Sanctuary is one of 15 sites and two marine national monuments managed by NOAA's Office of National Marine Sanctuaries as well as one of two in the Great Lakes to protect one of the best preserved and nationally significant shipwreck collections. The 4,300 square mile site is headquartered in Alpena, Michigan and is one of the most treacherous stretches of water within the Great Lakes System due to its unpredictable weather, murky fog banks, sudden gales, and rocky shoals. The site has been named 'Shipwreck Alley," and nearly 100 shipwrecks have been found in the sanctuary. NOAA and the State of Michigan comanage the sanctuary and work with various partners to encourage sustainable tourism and foster greater awareness of the Great Lakes and their rich maritime heritage. The sanctuary's Great

Lakes Maritime Heritage Center has become a major tourism destination in the region with more than 10,000 square feet of interactive exhibits and its ability to host events and programs (e.g. Thunder Bay International Film Festival and Maritime Festival).




Figure 3-1 Thunder Bay National Marine Sanctuary Atlas Map

On September 5, 2014, NOAA released a final rule and environmental impact statement expanding the boundaries of Thunder Bay National Marine Sanctuary from 448 square miles to 4,300 square miles to include the waters of Lake Huron adjacent to Michigan's Alcona, Alpena, and Presque Isle Counties and to the Canadian border (Figure 3-1). Divers and non-divers both enjoy the shipwrecks through chartered diving, glass-bottom boat tours, snorkeling, fishing tours, stand-up paddleboarding, and kayak and canoe rentals.

Presque Isle District Library

Description

The District Library has locations in Rogers City, Onaway, Posen, Presque Isle Township, and Millersburg.

US 23 Heritage Route

Description

The US 23 Heritage Route extends 200 miles from Standish to Mackinaw City. Each county along the route has an active Heritage Route Team and participates in an overseeing Management Council, which works toward implementing projects in the US 23 Heritage Route Management Plan. The Presque Isle County Heritage Route Team consists of volunteers interested in tourism and history.

Huron Blueways

Description

The Huron Shores Coastal Water Trail is comprised of 200 miles of scenic views along Lake Huron from Standish to Mackinaw City. Key trail destinations in

Presque Isle Township include Presque Isle Harbor, Old & New Presque Isle Lighthouses, Range Light Park, and various shipwrecks.

Sunrise Coast Birding Trail

Description

The Sunrise Coast Birding Trail is a designated bird watching trail with several parks and viewpoints along the coast of Lake Huron.

Private and Semi-Private Recreation Facilities

Presque Isle Harbor Association

Description

The Presque Isle Harbor Association is a private membership Home Owners Association that includes a clubhouse with a pool, game room, gym & exercise room, North Bay beach/beach house, Grand Lake common area with boat launch, swimming beach, picnic area, playground, boat rentals, a 60-site modern campground, Lake Esau Park, Burnham's Landing Park, and nature trails.

Presque Isle Yacht Club

Description

The Presque Isle Yacht Club is a private membership organization, which promotes activities, tourism, and comradeship among boaters. The yacht club donated complimentary bikes for use by visiting boat owners, which are tended by the Portage Store & Deli.

Presque Isle Lodge

Description

The Presque Isle Lodge is a privately-owned bed and breakfast lodge that hosts special events between Lake Esau and Grand Lake in Presque

Isle Township. It is listed on the National Register of Historic Places.

Grand Lake Association Park

Description

The park is maintained by the Grand Lake Association and offers a tennis court, basketball

court, volleyball court, and playground equipment. The historic Kauffman House is used as a gift shop.

Camp Chickagami

Description

Camp Chickagami is a 100-acre private recreational group camp on the north end of Lake Esau. The camp is owned by the Episcopal Church Diocese of Eastern Michigan, and contains Fletcher Hall (meals

and indoor recreation), St. Andrew's Chapel, a beach, fields, trails, campfire sites, three lodges, and cabins and dorm units.

Parker House

Description

Located on four acres, the Parker House offers rental cabins, a dock on Long Lake, a restaurant, and an ice cream shop.

Fireside Inn

Description

The Fireside Inn is a historical site that offers rental cabins on Grand Lake. It has a restaurant, tennis courts, volleyball, ping-pong, horseshoes,

shuffleboard, a playground, canoeing, kayaking, walking trails, and a 9-hole disc golf course.

Grand Lake Hotel

Description

The Grand Lake Hotel offers cabins and cottages for rent, a tennis/pickleball court, a firepit, a

sundeck, and a dock. Boats are not supplied, but rental companies can be found in the area.

Presque Isle Township Recreation Plan

Planning Process

The development of a community recreation plan must involve interaction and input from citizens and community groups. The Parks and Recreation Committee was the lead entity in developing the recreation plan. The Parks and Recreation Committee, Planning Commission, and Township Board of Trustees meetings were open to the public with time allocated for comments. A timeline for the recreation plan update can be found below.

Schedule

August 2022 Presque Isle Township contracts with the Northeast Michigan Council of Governments

(NEMCOG) to assist with updating the township's master plan and discusses future

updates to the Presque Isle Township Recreation Plan.

September 2022 NEMCOG Staff drafts the public survey for the master plan update.

November 2022 NEMCOG Staff added recreation-related questions to the survey per Presque Isle

Township's request. Presque Isle Township includes flyers about the public survey in

the winter tax bill mailings.

December 2022 The public survey is made available to the public, and is advertised and posted on

Facebook & Instagram pages, including *Presque Isle Township Parks & Recreation, Pure Presque Isle*, and *Presque Isle Happenings*. Presque Isle Township contracts with

NEMCOG to assist with updating the township's recreation plan.

January 2023 NEMCOG Staff closes the public survey.

September 2023 The Parks and Recreation Committee and NEMCOG Staff review draft recreation plan

chapters and discuss facility needs.

October 2023 The Parks and Recreation Committee and Planning Commission review and update the

recreation plan's goals, objectives, and action plan.

November 2023 A public notice about the plan's availability for a 30-day public review and public hearing

was published in the Presque Isle County Advance and was posted on social media and

at the Township Hall.

The draft plan was posted for a 30-day public review period on NEMCOG's and Presque

Isle Township's websites, and hardcopies were available at the Township Hall, the

Presque Isle Harbor Association Clubhouse, and the library.

December 2023 The public hearing was held during a joint meeting between the Parks and Recreation

Committee and the Planning Commission. Public comments were received in regards to updates to the recreation inventory, action items, and the community description. The Parks and Recreation Committee responded to the comments. The Planning Commission passed a resolution to adopt the plan with amendments, and to recommend the Township Board adopt the amended plan. The Township Board passed

a resolution to adopt the recreation plan.

PLANNING PROCESS

Public Input

Citizen opinion on recreation priorities is vital to the development of a recreation plan. An online survey was offered to citizens to gain input for the development of a new master plan, which included several questions about recreational facilities and services in the township. The survey was open for approximately three months and had 422 people who participated, although not every person completed all the survey questions. The survey results can be viewed in Appendix A-1 or by contacting the Planning Commission. The Parks and Recreation Committee felt the community was well-represented throughout the process.

Basis for Action

- 1. Presque Isle Township has a significantly older population with individuals aged 65 years and older comprising about 37.3% of the population compared to the State of Michigan at 24.2%. The majority of migration into the township is from persons aged 60 years and older. Therefore, this large population has the time and desire to participate in age appropriate recreational activities and should be given consideration during the planning process. In addition, approximately 31.7% of the township's population is under the age of 45 and have very little access to age appropriate recreational activities and programs due to the township's rural nature.
- 2. Natural beauty and history are found throughout Presque Isle Township, and it is important to consider how people will get to the park & recreation site, if they are able to move freely within the site, and if they are able to pay required fees.
- 3. The township has about 46.2% of its homes classified as vacant or seasonal and should plan for seasonal recreational opportunities accordingly.




