CDC/RPI Topic Discussions

<u>10 year RPI Plan</u>: Various upcoming meetings. 3 levels: collaborative, council, board for funding. Various levels require 10 year plan. Probably won't be combining the8+3 counties due to legal issues. NW is the only one that has done this, but they're boundaries in the RPI perspective have not changed. Still a good idea to have a region plan regardless how the plan changes over the 10 years. RPI is seed money, but identify and support RPI with other funding options. Having the 10 year plan gives us more options. (Sara Lucas, contact regarding CEDS)

3 year Plan/Amend: Option to add 3 changes to it. Should the opportunity to act on it comes up within the next 1-3 years. No budget amounts for those changes yet. Group thinks those items can fall under other line items that already are listed in the current plan.

RPI Plan for FY17 application (due by the end of December) draft was handed out. Retention visits should be removed : The plan should be done in next week or two to review for application submission. Will communicate via email to get information/decisions without having to meet in November. (Diane-Budget and application in by November/Dave-10 year plan by end of December.) RPI Plan in on the website; you can refer to it while looking over the draft of 1 year budget before giving input.

J. McNabb: A lot of focus on career opportunities. Input she has "doing better", but still having challenges. Such challenges as wages and people. Word is getting out. Using MI Works! is a great option vs head hunters, etc. Need a way to let down-staters know that there are jobs here. Also, housing needs and skilled people such as electricians and plumbers. Some business' are posting wages on bill boards, encouraging employees to leave their current employment and move to a new job. If there is something working, you can build on it to expand to other areas. As age changes, needs change, infrastructure has to match to those needs. "Go Pro": new program like Pure Michigan. Tourism is vital in our plan, 10 years from now perhaps "managed" tourism-wood industry, health industry. Retirees are the ones to focus on if millennials want to go to busier towns and cities.

Promoting townships, villages, cities, etc. so they know Prosperity exists (awareness).
