# **Chapter 9 - Mitigation Strategies and Priorities**

The next step in the hazard mitigation planning process is to identify mitigation actions suitable to the community, evaluate the effect the action will have on the specified mitigation objective and prioritize actions to decide what sequence or order these actions should be pursued.

### **Mitigation Categories**

Mitigation actions can be grouped into six broad categories:

#### 1. Prevention:

Government administrative or regulatory actions or processes that influence the way land and buildings are developed and built. These actions also include public activities to reduce hazard losses. Examples include planning and zoning, building codes, capital improvement programs, open space preservation, and storm water management regulations.

#### 2. Property Protection:

Actions that involve modification of existing buildings or structures to protect them from a hazard, or actual removal from the hazard area. Examples include acquisition, elevation, relocation, structural retrofits, storm shutters, and shatter-resistant glass.

### 3. Public Education and Awareness:

This form of hazard mitigation involves actions to inform and educate citizens, elected officials, and property owners about the hazards and potential ways to mitigate them. Such actions include outreach projects, real estate disclosure, hazard information centers, and school-age and adult education programs.

#### 4. Natural Resource Protection:

This category includes actions that, in addition to minimizing hazard losses, also preserve or restore the functions of natural systems. These actions include sediment and erosion control, stream corridor restoration, watershed management, forest and vegetation management, and wetland restoration and preservation.

### 5. Emergency Services:

Emergency services provide actions that protect people and property during and immediately after a disaster or hazard event. Services include warning systems, emergency response services, and protection of critical facilities.

### 6. Structural Projects:

Structural mitigation projects include actions that involve construction of structures to reduce the hazard impact. Such structures include dams, levees, floodwalls, seawalls, retaining walls, and safe rooms.

# **Identification of Mitigation Projects and Actions**

The public was invited to a meeting held in Montmorency County on May 27, 2004, to discuss and identify hazards and possible mitigation actions and projects that would help lessen hazard vulnerability in Montmorency. Community and agency officials, LEPC members and general public were invited to attend the workshop that was held in conjunction with the Montmorency County Local Emergency Planning Committee.

### **Evaluation and Prioritization of Mitigation Actions**

Members of the Montmorency LEPC met on October 18, 2004, to evaluate and prioritize the list of mitigation actions that were identified at the May 27, community-wide meeting.. Governmental level, agencies and organizations that could carry responsibility for completing the respective actions and possible funding sources were also identified. Evaluation criteria included: social impacts, technically feasible, administrative capabilities, political impacts, legal issues, cost effectiveness environmental, and overall benefit to the community. Appendix C shows the projects and associated evaluation criteria.

The Mitigation Committee used a normative ranking process to prioritize and rank the list of projects compiled at the earlier session. The planning team chose to use an approach termed "multi-voting." Actions were ranked by hazard type. Each participating member was given a number of selections equal to approximately half the total number of potential actions listed. In other words, if there were 20 mitigation actions for wildfires, participants could vote for 10 of the actions. In some cases additional projects were selected. It was decided by the Mitigation Committee that rather than rank the respective projects they would identify the projects as either priority or not priority. Those items that did not qualify as "priority projects" are included at the end of the list for each hazard type, if they were considered applicable to the county situation. Therefore, all actions that were considered relevant by the committee are included somewhere on the list.

Next, the committee identified possible responsible governments, agencies and organizations that might provide general funding for the respective projects. Specific site application and an anticipated timeframe for completing the actions were also estimated.

#### **Review and Updating Hazard Mitigation Action Items**

The Committee reviewed the 2006 Mitigation Strategies and made necessary changes. Several action items were eliminated or combined. Actions that have been completed were eliminated. Time lines were altered on mitigation strategies. The 2006 mitigation strategies list is attached to show changes in the document.

Changes in local land development have been negligible given the 2007 nationwide recession. The committee did not identify areas with significant land development since the last plan was completed and therefore made no changes to the plan in relation to new development.

Most activities in the hazard mitigation plan that the community has worked on are related to ongoing mitigation actions.

The committee made minor changes in priorities in the Public Health by elevating its risk and adding strategies.


