ALPENA TC AND PC DISCOVERY MEETING

The Technical and Policy Committees (TC/PC) representing the Alpena Combat Readiness Training Center (CRTC) met June 1, 2017. 1:30 – 4:00 p.m. Tetra Tech provided a briefing and facilitated the meeting. Residents were asked to identify where they live in relation to the JLUS AOI, provided a brief introduction on who they are and their interest in the Joint Land Use Study (JLUS). Tetra Tech provided an overview of the JLUS organization and process as well as facilitated a brainstorming session to help identify potential issues that the JLUS should address.

Alpena TC/PC: Issues Identification

The following bullets are issues and discussion captured during the Issue Identification with the Alpena area TC and PC.

- Flight Path several of the planes that go over with cargo nets travels over homes. Helo carrying a generator. Sling load training should not be traveling over homes but there are some accidental traveling
- Bomb runs over lake Huron and removal of UXO/Dummy Ordinance
- PFC/PFOS/and PFOA
- Off shore training runs. Live munition impact on habitat.
- Infrastructure issues assistance for road repair. Military uses public infrastructure and doesn't match SRM
- Noise from training in recreational areas
- Approach/departure is determined
- Airport location awareness/noise awareness
- Economic impact is mixed. But there is an Economic Impact for Aplena CRTC. Trades jobs are a positive economic impact.
- New hangar that will be a large project with significant economic impact.
- Alpena CRTC plans to use local hotel for surge capacity over 1100. They use local barber shops, laundry mat,
- Northern Strike 1500 vehicles for rent
- Joint response emergency services exists. They have a mutual aide agreement
- Sherriff/Security partnership
- .25 million gallons of JP8. During Northern Strike they burn 800K gallons of various fuel that is purchased from the local community
- Northern Strike also has increased traffic activity
- Northern Strike one year an exercise damage historical structure on Thunder Bay Island
- With many transient people coming through for exercises, they have had issues. CRTC has stepped up their education people receive when they arrive.
- Better way to for locals to notice economic impact would be great
- What is the land use and environmental carrying capacity to support the training activities?
- What is the munitions impact on ground water?
- Potential breach of security is low, but not impossible.
- Civilian intrusion into military area.
- Training accidents have occurred during hunting season.
- Sharing knowledge between NEMCOG and CRTC. They have PA, which is the base commander. This would have helped in 2009 and 2015 when the base was considered for closure. Alpena has the fewest NEPA sites for clean-up. Developing a base community council would help.
- PSAs are helpful.
- Community should reach out and draw people into the community. Both for tourism and population growth.

Alpena TC/PC: SWOT Exercise - Discussion

- They have an airfield joint use agreement. CRTC only maintain their roads. But runway maintenance is an issue.
- The base has above average use water use. So, sustainability could be an opportunity for the base. CRTC has solar panels, but limited results due to weather.
- TheWings over Alpena, public air show was enjoyed by the community and would likely welcomed. Quick or small community parade during Northern Strike.
- Increase CRTC community involvement would be nice.
- How do we get contractors/private firms to consider this a potential home. NE Michigan UAS/ATVs?
- The airport is county property.
- CRTC and airport has expansion capacity.
- They have a GSU

GRAYLING TC AND PC DISCOVERY MEETING

The Technical and Policy Committees (TC/PC) representing the Camp Grayling Joint Military Training Center (JMTC) met June 6, 2017. 9:00 – 11:00 a.m. Tetra Tech provided a briefing and facilitated the meeting. Residents were asked to identify where they live in relation to the JLUS AOI, provided a brief introduction on who they are and their interest in the Joint Land Use Study (JLUS). Tetra Tech provided an overview of the JLUS organization and process as well as facilitated a brainstorming session to help identify potential issues that the JLUS should address.

Grayling TC/PC: Issues Identification

The following bullets are issues and discussion captured during the Issue Identification with the Grayling area TC and PC.

- Impact area noise, aircraft operations, traffic.
- Wildfires. 2015 col. Brown has list of acres burned (see slide provided to us as HC).
- Fire containment is the biggest issue for Col Brown.
- Wildfire smoke can also be an issue.
- Disaster Communication is also important. Wildfires and otherwise.
- Traffic Congestion: Summer tourism and NG convoys are an issue. Sometimes convoy release schedule is released. But sometimes units leave early. Riverfest, and Car Show, all seem to happen at the same time.
- There are also problem intersections including freeway interchanges. Poorly designed and not enough capacity. 4 mile exit/75.
- Worlds largest XXXXX plant being built. Logging truck traffic will increase.
- Road condition due to convoys.
- Also, roads through the ranges/interior roads impacts natural resources. Water quality is impacted. Sand in the river. Loss of habitat. Soil erosion.
- Water Quality: ground water contamination. Storm water is an issue into the river. Siltation and sedimentation.
- Energy consumption/efficiency: the ANG Air to ground range facility is one of their largest energy hogs.
- Virtual pipeline for natural gas.
- Economic impact
- Public relations
- Boundary management: The military wants to make sure that the property they own is the property the need. If they don't need it, they don't want it. And they are putting some up for sale.
- They also have properties that they want to keep that are surrounded by private property.
- Public access: legislative action 288
- Geographically centered guard presence: provides disaster/defense support for community.
- The Grayling airport/airfield could potentially at risk depending on funding priorities. Camp has a 2025 plan for expansion. Everytime they expand the airfield there are issues around trees that come up.
- Water Contamination: PFOS/PFOA
- Emergency responders: it's a broad issue with interagency response especially during busy times of year. It could be capacity and logistics.
- Northern Strike: The town is unable to support. Use all the beds on base and in Grayling.
- Public recreation
- Wildlife habitat: T&E, wildlife partnerships, and contagious habitat.
- Airspace: large area, restricted airspace for UASs. Certificate of Authority for UAS to restricted airspace. COAs mean that you don't have to line of site for. But they do have to have line of sight until until they get to the restricted.

- Military exercises: increased throughput. Provides year round impact and when the plus up occurs the economic impact is even greater.
- Frequency spectrum: There are pros and cons. One pro is that it brings in a lot of military research and development. Interoperability: they try to solve it internally.
- T&E research: military provides a lot of. There is other research as well: Windtunnel, cool bridge thing.
- Social media is highly used. And a good public relations tool.
- Wildfires: loss of training time, property loss, prescribed burns (all fires have issues)
- Infrastructure: roads, bridges, utilities, internet connections, cell phone connection, facilities (they are tool that the community can use, such as the NCO club).
- The HB288 may increase traffic on the base of citizens on base with ATV. Trails are being busted open.
- Kirtland Warbler and Snake and Bat: these are things that could take the base down.
- UASs can be an opportunity as well as a strength.
- Visitors tail: we will lose people if we don't know how to keep them here.
- T&E is viewed as a strength because they strike a balance of recognizing.
- MI Guard and Alpena CTRC uses Rave Alert to send out disaster updates. Something to look into for public notifications.

Grayling Area Public Meeting

- Land ownerships. Public access to hunting, especially at and near Range 40. PA288 will come out with a map ORV; cooperative effort between DNR and Camp Grayling
- Road conditions and tax burden.
- New runway and tree clearing: Runway expansion need more communication. Base is looking at underground power to reduce tree clearing. Will aircraft come down over civilian property? There is regulation on aircraft approach. FAA guidance has changed in the last five years. This is a critical issue that needs to have an implementation strategy
- Positive experience with boat launches and fishing.
- UXOs; 30, 40, and beaver ranges all have UXOs. They have a detachment on base that goes out and looks and retrieve UXOs. If one doesn't go off, the training stops until retrieved.
- Multi country collaboration pointed out by base, but sometimes it has caused an issue.
- Noise improvement from 25 years ago.
- Lack of real internet access
- Night time operations are a problem with noise.
- A way to work with DNR based on their tree plan that helped block sound. Unsure if that is scientifically true. However, there is a perception. Communication is a problem. DNR also appears to clear cut and displace wildlife.
- Threatened and Endangered species habitat is being developed on Camp Grayling to help
- Economic Impact is positive; could the military representatives meet with surrounding areas/counties and describe what is happening on base.
- There is property that the military doesn't need and they would like to turn it over back to the community, especially outside the main cantonment. Conversely, they would be interested in purchasing property that is surrounded by the installation. In/Out Grant
- Sound and view buffer in Sherwood Forrest
- Infrastructure in disrepair looking for help from the government or state to repair.
- Cell phone reception is poor.
- If the installation grows, how will they management. Communication about operations.
- Approach and departure zones. Why are they flying over the subdivions.
- The military has also has started to have simulation training which reduces environmental and noise impact.
- Wide name recognition of CampGrayling/NG and historic reputation.
- Wildfires
- The Camp is much more open from years past and the community appreciates the improvement.
- The Camp has a 5 year expansion plan. Some of it will come back to things identified in this process. They won't have any land growth but they want to increase mission, specifically tanks, at MATES. Northern Strike wants to go twice a year. Number of exercises will increase, number troops will increase. So the pros and cons of traffic congestion and economic development.

- Trying to get a cell tower. ATT wants more than what the guard can bring to help bring more cell phone service and internet.
- If Alpena goes away, the mission won't come to Camp Grayling.
- Ammo and Fuel supply do we have enough security and emergency response.
- Emergency response Fire, Police, don't have resources during peak seasons.
- Improvement of community relationships and the guard is appreciated.
- Recycling/lead abatement and brass abatement on base is impressive.
- Grayling township can't get recycling done. Camp isn't sure how to get citizens on post and they would need to build a larger facility. Possible Joint Facility should be considered.
