# Chapter 1

## Community Description

---

### Extent of Plan Focus

This Recreation Plan addresses recreational facilities and plans within the boundaries of Alcona Township. The plan will evaluate the surrounding recreational opportunities as well as the socio-economic status of the Township and the surrounding area in order to determine recreational needs of the population and to plan for improvements which fit those needs.

### Regional Setting

Alcona Township is an L-shaped township located in the northeast corner of Alcona County in Town 28 North, Ranges 7, 8, and 9 East. The Township contains approximately 58 square miles of land area and nine square miles of Hubbard Lake. The township is bordered by Alpena County at its northeastern edge. Caledonia Township borders it for part of its northern and western limits. Hawes and Haynes Townships make up its southern border. The eastern boundary is Lake Huron, which gives Alcona Township more than 10 miles of Great Lake shoreline. The distance from the north to the south boundary, at the widest point, is six miles. From east to west, the township stretches for more than 17 miles.

Traffic circulation north and south within the township is along Lakeshore Drive, which follows the shoreline of Lake Huron; Highway U.S. 23, which parallels the shoreline further inland; Highway F-41, which runs north and south several miles inland; and Hubbard Lake Road, which runs along the southeast shore of Hubbard Lake. The major east-west route is Black River Road.

Figure 1-1: Regional Location




Figure 1-2: Alcona County Base Map





Figure 1-3: Alcona Township Base Map



Alcona Township is ideally situated for year-round outdoor recreation. The Township is located on the east side of Alcona County, on beautiful Lake Huron and reaches into central Alcona County extending across and beyond the mid-section of Hubbard Lake.

## **Population**

According to the U.S. Census Bureau, the population for Alcona Township in 2010 was 968 persons. In reviewing the 2010 Census data, the figures presented for housing characteristics show 1,366 total units with 806 units as seasonal, recreational, or occasional use homes. Based on the average household size in Alcona Township of 1.95, the expected seasonal increase would be approximately 1,572 persons, nearly doubling the year-round population. In addition, many seasonal or recreational visitors stay at private lodging places or at the homes of family or friends.

## **Water Resources**

Alcona Township has nearly 10 miles of shoreline along Lake Huron. Approximately nine square miles of Hubbard Lake are contained within this Township. Several other lakes are located within the Township in the private, gated community of Lost Lake Woods. Lost Lake (T28N, R8E) has 14 acres; Bear Lake (T28N, R8E) has 15.7 acres; Deer Lake (T28N, R8E) has 48 acres; Badger Lake (T28N, R8E) has 83 acres; and Muskrat Lake (T28N, R9E) has 6 acres.

The Black River flows through the Township from north to south. Stevens Creek, Sucker Creek, Little North Creek, Liston Creek, Silver Creek, Gauthier Creek, and Derocher Creek are all located within Alcona Township.

## **Forests and Wildlife**

Based on the current plat book for the county, a significant amount of the land is owned by the federal and state government, and that land is maintained as forests. The Huron National Forest covers more than six square miles of Alcona Township. The Au Sable State Forest stretches for several square miles in the Township. A portion of Negwegon State Park is located in Alcona Township. The federal government owns several other parcels of land in the southeast corner of the Township. In addition to this government ownership, a private club holds more than 10,000 acres of land.

The forested areas provide the chief habitat for many game species. Among these are deer and bear, as well as fox, rabbit, raccoon, squirrel, and bobcat. Game fowl include ducks, geese, ruffed grouse, woodcock, and turkey. In addition, the lakes and streams support many fish species.

## **Topography**

The topography of Alcona Township is gently rolling and hilly. Elevation varies from 500' near the Lake Huron shoreline to 800' as one travels westward. Near the shores of Hubbard Lake,

the elevation drops to 700'.

## **Land Use Pattern**

Of the 58 square miles of land in the township, approximately 14 square miles are owned by a single private club. Approximately ten square miles make up Huron National Forest and other federal forestlands. About four square miles are in the State Parks, including Au Sable and Negwegon State Parks. Private ownership, which accounts for the rest of ownership of the township, holds approximately 30 square miles. Nine square miles of Hubbard Lake is included in this township. Figure 1-3 details this land use pattern.

# Chapter 2

## Administrative Structure

---

### **Administration**

The Township of Alcona is governed by an elected Board of Trustees. This board is responsible for all recreation decisions in the Township. The Board receives recommendations from the Planning Commission. The Planning Commission advises the board regarding the planning, acquisition, development and funding of all other recreation properties and facilities within the Township. Membership in these two committees is currently being determined. Among other township governmental entities are the Zoning Board of Appeals and the Board of Review.

### **Planning Commission**

The Alcona Township Planning Commission is a five member body, serving three-year staggered terms. Planning Commission members are intended to represent the township geographically and across a broad spectrum of community interests, including recreation, commerce, industry, government, education, transportation, and so on. Planning members may come from many walks of life, but they all contribute their time and talents to the local planning process. In addition to the responsibility of preparing the Master Plan, the Alcona Township Planning Commission is charged with reviewing development projects as they are proposed.


### **Staff/Parks & Recreation Maintenance**

Alcona Township employees a contractor to provide lawn maintenance and snow removal at its Parks and Recreational facilities. Other volunteers have contributed time to clean restrooms and plant flowers over the years. A volunteer day was also held during which volunteers trimmed trees, picked up limbs, repaired picnic tables and painted some structures.

## Alcona Township Budget

In the Township, finances are garnered from property taxes, permits and fees. Maintenance operations for the Township properties are the responsibility of the Board of Trustees. The Board allocates funds for the performance of maintenance tasks. The purpose of updating the Recreation Plan is to establish the groundwork necessary for the Township to be able to seek funding from grant applications. The Township will utilize contingency funds that have been set aside to use as matching funds.

### Funding for the Parks & Recreation Budget

The current Township budget allocates \$15,000 for recreation through March of 2015. An additional \$5,000 is allocated for the Harbor which usually involves dredging the river mouth. An identical budget for recreation is allocated for FY 16.

## **Relationship with Other Agencies & Role of Volunteers**

The Township of Alcona depends on its community volunteers. These are dedicated individuals who come forward time and again to assist with community improvement projects, festival preparations and other community events. The Township Board has frequent contact and excellent rapport with local/adjoining Township Officials and County Representatives whom they work with on various projects.

Alcona Township has relationships with the following groups:

1. **Hubbard Lake Sportsmen & Improvement Association (HLSIA).** Two of the Planning Commissioners are members that share information relevant to our community.
2. **Lost Lake Woods Club (LLWC).** LLWC houses Fire Station 3 and has a group of volunteer first responders.
3. **Negwegon State Park.** The Township provides an access road into the park and has occasional contact with The Friends of Negwegon.
4. **Thunder Bay National Marine Sanctuary.** Staff from TBNMS have assisted the Township with determining that there are shipwrecks off the Township shoreline and have encouraged the Township to seek the advancement of improvements to the area to bring additional recreation opportunities to our community.

# Chapter 3

## Recreation Inventory

---

An inventory of recreation facilities available in Alcona Township was completed and is presented in this chapter. The inventory includes Alcona Township owned facilities, Alcona County owned facilities, State and organization owned facilities, and privately owned facilities. Alcona Township owned facilities were evaluated for barrier-free accessibility. A description of the barrier-free accessibility rating criteria is provided below, in figure 3-1.

### INVENTORY PROCEDURES

The methods used by NEMCOG staff to compile this recreational inventory include verification and compilation of information from the previous Recreation Plan, and information provided by Alcona Township officials. Compiled information was compared to existing information to ensure consistency and/or accuracy.

**Accessibility Assessments** - An assessment of the accessibility of each park to people with disabilities. This assessment must consider the accessibility of both the facilities themselves (as appropriate), as well as the access routes to them. The barrier-free accessibility information and sources of assistance given in appendices B and D should be consulted when making this assessment. At a minimum, use the following ranking system for each park:

- 1 = none of the facilities/park areas meet accessibility guidelines
- 2 = some of the facilities/park areas meet accessibility guidelines
- 3 = most of the facilities/park areas meet accessibility guidelines
- 4 = the entire park meets accessibility guidelines
- 5 = the entire park was developed/renovated using the principals of universal design

## Township Recreation Property

### Property

- 1. Black River/Lake Huron:** The Township owns this three acre site, which includes 1.5 acres adjacent to the river with 200' of river frontage; and 1.5 acres with 160' frontage of sandy beach on Lake Huron. These properties receive considerable use as a boat launch site, and for picnicking and swimming. They contain a picnic pavilion, two grills, multiple picnic tables, and minimal playground equipment. Because of the increased usage, future expansion plans include adding additional picnic tables and grills; replacing the playground equipment, which is outdated and deteriorating; installing a kayak/canoe launch; improved restroom facilities; paved parking and driveway; installing ADA compliant boardwalk to Lake Huron shoreline; creating a volleyball court; installing rip rap or steel piling along the north shore of the Black River bank to control silting; and improved signage to and within the park. The township presently dredges this area annually to control silting, the annual cost of which is between \$3,000 and \$3,500. The Township is also considering replacing wooden fencing with maintenance free vinyl fencing, reducing upkeep and material and labor costs each year.




In addition, located between these parcels is a 200' by 800' parcel recently acquired by the township from the MDNR through a twenty-five year lease agreement, which greatly increases the township's recreational capabilities at this expanded location.

**Type:** Special Use Area

**Service Area:** Township

**Barrier-Free Accessibility = 2** (some of the facilities/park areas meet accessibility guidelines).

Concrete sidewalk from parking lot to various locations within the park. The rest of the property is primarily seeded lawn and the walking path to the beach is sand, making access to Lake Huron difficult for patrons with disabilities.



2. **Eastshore Hubbard Lake Public Access:** The Township maintains one launch/access site for small boats, canoes, kayaks, and other small watercraft. In the future, the Township would like to develop this 53' wide by 200' long site by stabilizing the shoreline from erosion. During the winter months this site is used as an access to the lake by fishermen and snowmobilers. In the past, there have been problems with vehicular traffic accessing the ice and disrupting the shoreline in the process. The Township would like to limit access to ATV and snowmobile traffic by means of fencing or a retaining wall with a narrow access point above the high water mark of the lake.

**Type:** Special Use Area

**Service Area:** Township

**Barrier-Free Accessibility = 1** (none of the facilities/park areas meet accessibility guidelines). The property is primarily undeveloped and therefore lacks features and other facilities, which support the recreational needs of the disabled.



3. **Black River Recreation Area:** The Township maintains three acres in the Village of Black River. This area contains a basketball court, one tennis court, a baseball field, a small playground set, one grill, and pit-type toilets. The pond has been/can be used as an ice-skating rink. This area needs considerable site enhancement, including landscaping, fencing upgrades on the ball field and stripe painting on the tennis court and basketball court. The Township would like to add amenities to this site to improve recreational opportunities and usage by residents and visitors including a new pavilion, picnic tables, another grill, and improved restroom facilities.



**Type:** Community Park

**Service Area:** Township

**Barrier-Free Accessibility = 1** (none of the facilities/park areas meet accessibility guidelines). The property lacks features and other facilities which support the recreational needs of the disabled.



## Public Buildings

4. **Township Hall and Fire Station #1:** Located at the corner of Black River Road and U.S. 23, this property consists of approximately 2 acres. The building is a combination fire hall and township hall.

**Type:** Special Use Area

**Service Area:** Township

**Barrier-Free Accessibility = 2** (some of the facilities/park areas meet accessibility guidelines).



5. **Fire Station #2:** Situated on approximately 1 acre, this property is used solely as a fire hall. There are no plans in sight for improvement.

**Type:** Community Park

**Service Area:** Township


**Barrier-Free Accessibility = 1**

- 6. **Negwegon State Park:** Owned by the State of Michigan, this land consists of approximately 1,720 acres along the shores of Lake Huron, with the possible inclusion of an additional 1,265 acres in the future. The southern portion of it is located in Alcona Township, while the remaining portion is in Sanborn Township in Alpena County. A gravel entrance road and parking lot currently exist to this large wilderness area. In addition to swimming and picnicking opportunities, there are currently 11.6 miles of marked hiking and nature trails. Camping is permitted at four primitive, walk-in sites that require reservations. Campsites can be accessed by kayak/canoe from Lake Huron. Hunting of deer, turkey, rabbit, woodcock, duck, goose and squirrel is permitted.
  
- 7. **Huron National Forest:** Owned by the United States Government, this land consists of approximately 5,400 acres. It includes almost one mile of undeveloped shoreline along Lake Huron. No developed recreational facilities are planned for this area.

Privately Owned Recreation Facilities

- 8. **Lost Lake Woods Club:** This is a private club consisting of approximately 10,000 acres, a 40-room clubhouse and four private lakes. The club has complete recreational facilities including hunting, fishing, hiking trails, snowmobile and riding trails, a riding stable, 18 hole golf course, archery range, skeet and rifle ranges and year-round homes. The club, although private, has a tremendous impact on Alcona Township and Alcona County.

There is also a fire station (Fire Station #3) located on this property. The building is owned by Lost Lake Woods Club and the fire truck is owned by the Township. This cooperative arrangement with the township exchanges facilities for housing fire-fighting equipment in return for fire-fighting services.

Following is a detailed description of significant recreational sites in Alcona County (numbers represent the facility on Map 4-2 Regional Recreation):

**ALCONA COMMUNITY SCHOOL DISTRICT (#1):** Alcona Community School District encompasses approximately 426 square miles in Alcona County. The 54 acre rural school campus houses Alcona Elementary School, Alcona Middle School, Alcona Community High School, NEMCSA Headstart, a transportation center, outdoor athletic complex, and a 650 seat community auditorium. Recreational and educational facilities available for community use include three gymnasiums, a weight room, an 8-lane all-weather rubberized track, baseball diamond, softball diamond, football/soccer stadium, football practice field, five locker rooms, two playground areas, two media centers with computer facilities, four computer labs, one interactive television lab, a mobile interactive television unit, two cafeterias, a fully-equipped 650-seat auditorium with stage, light and sound booth, and dressing rooms, and conference and classrooms throughout the district. Community members are welcome to access district facilities through a facility use policy developed by the Alcona Community Schools Board of Education and with district approval.

**ALCONA RECREATION AREA (#2)** is a 123-acre County-owned site located in the northeast corner of Harrisville Township. The area is the site of the Alcona County Fair as well as the Lincoln 250 Enduro Snowmobile Race. The location has a one-half mile dirt track for trotter and snowmobile racing, a Motocross track, four pole barns, four animal barns, a multipurpose building for displays, meetings and other events, a horse arena and show arena, an office and maintenance building with flush toilets, a 300' complete BMX track, an observation/broadcast booth, a gatehouse, two wells, four irrigated soccer fields, water and sewer, six portable toilets, and 80 acres of undeveloped forest land. It also boasts a Braille Nature Trail.

**STURGEON POINT LIGHTHOUSE (#3)**, located in Haynes Township, is a major tourist attraction. The Alcona Historical Society offers summer tours of the still-operating, Federally-owned facility. The State of Michigan owns the 40 acres surrounding the lighthouse and has no immediate plans for development. **Old Bailey School**, one of the few remaining one-room, log schoolhouses in Michigan, is situated near the lighthouse and is open to the public. **HARRISVILLE STATE PARK (#4)**, at the southern City limits, and **ALCONA PARK (#5)**, near Glennie in Curtis Township, offer modern camping facilities. **NEGWEGON STATE PARK (#6)** is an unimproved state park, which currently includes 3,378 acres of land, falls partly in Alcona

Township in Alcona County and partly in Alpena County's Sanborn Township. Present facilities allow for primitive camping and provide hiking and nature trails.

The **GREENBUSH RECREATION AREA (#7)** is a 34-acre site with an open-air pavilion, two ball fields, a children's playground, nature trails and picnic areas. Bathroom facilities are also available. **THE PINE RIVER NATIONAL FOREST CAMPGROUND (#8)**, located at the former state trout-rearing ponds in the Huron National Forest in Mikado Township, offers eleven primitive campground sites with toilets and hand-pumped water, a picnic pavilion and grills. Three recreation sites are maintained by the U.S. Forest Service in Millen Township: **JEWELL LAKE CAMPGROUND (#9)**, **HORSESHOE LAKE CAMPGROUND (#10)**, and **REID LAKE QUIET AREA (#11)**. Each has primitive campsites, hand-pumped water, and picnic & foot trail areas. The Reid Lake site also offers over six miles of cross country ski trails. **THE HOIST LAKE AREA (#12)**, maintained by the U.S. Forest Service in Mitchell Township, has seven small lakes and over 20 miles of cross country ski trails. **GABIONS CAMPGROUND (#13)** in Mitchell Township offers camping and RV sites.

**FOREST LAND:** Approximately 74.5% of the land in Alcona County is forested, with State and Federal Forest areas comprising approximately 35.6% of it. Most of these areas are open to the public for hunting, hiking, camping and other outdoor sporting activities. Facilities on federal forests are utilized primarily for primitive camping, hiking, and wildlife observation.

**GOLF:** Alcona County has four public nine-hole golf courses: Greenbush Golf Course in Greenbush, Loggers Trace at Springport Hills south of Harrisville, and Monarch Ridge in Caledonia Township. There are also two 18-hole courses: Loggers' Trace at Springport Hills and White Pine National Golf Course in Spruce. Blackshire Hills, part of Lakewood Shores, is situated just to the south in Oscoda. In addition there is an 18 hole private course located in Lost Lake Woods Club.

**FLIGHTS OF IMAGINATION**, a play structure in Lincoln, is located on 11 acres of land in **BARLOW PARK (#14)**. (The park also includes softball and baseball fields, a wooded park and picnic area, tennis courts, and public restrooms). The play structure was designed by Robert A. Leathers & Associates, of Ithaca, New York for the children of Alcona County, as well as seasonal visitors to the area, and was funded and constructed using grassroots community efforts.

**THE LINCOLN DEPOT (#15)** is located in the downtown area of the Village of Lincoln and was restored by the Friends of the Lincoln Depot. It now serves as a tourist and educational attraction, and includes many of the original furnishings and a gift shop.

The **LINCOLN AREA MULTI-USE PATHWAY (LAMP)** travels through the streets of Lincoln and Barlow Park.

**SNOWMOBILE TRAILS:** There are 90 miles of groomed trails in Alcona County, while Oscoda County, to the west, has 121 miles and Iosco County, to the south, has 94 miles.

**TRAILS:** Three major hiking trail systems are located in Alcona County – the Hoist Lakes Foot Travel Area, Reid Lake Quiet Area, and approximately 14 miles of the Shore to Shore Trail passes through the southwestern portion of the county on its way from Lake Huron to Lake Michigan. Hoist Lakes (over 20 miles of trails) and Reid Lake (12 miles of trails) are footpaths for hikers and skiers while the Shore to Shore Trail is an unpaved multi-use trail for mountain bikes, hikers, and horses.

**SHIPWRECKS:** The boundaries of the Thunder Bay National Marine Sanctuary include the waters off Alcona, Alpena and Presque Isle County to the Canadian border. The sanctuary was designated to protect a significant collection of over 200 shipwrecks that lie in Lake Huron. Visitors can fish, kayak, or snorkel the wrecks. There are five shallow-water shipwrecks off the coast of Alcona Township accessible by kayak or small boat.

**THE BLACK RIVER ROUTE:** The Black River Route is a 24 mile round-trip self-guided bike tour beginning in Harrisville. Travel the Black River Route to historic points along the Huron coast. Historic sites you will view on this trip include the Village of Alcona (now a ghost town), Mt. Joy Cemetery (with graves from as far back as 1855), the Low School Site (which was opened to accommodate students during the lumbering era), and St. Gabriel Catholic Church (which was constructed in 1894 and has not been altered since).

**HUBBARD LAKE:** At 8,850 acres, Hubbard Lake is Michigan's 12<sup>th</sup> largest lake. Its depths range from 90 feet to less than 20 feet. The lake is oriented in a north-south direction which makes for prevailing winds coming from the west-southwest. Hubbard Lake provides water activities including boating, fishing, water skiing, swimming, personal watercraft operation, kayaking and canoeing. Three streams feed the lake: Comstock (West Branch River) at the south end, Sucker on the east side and Holcomb off of East Bay.

Figure 3-3: The Black River Route





Figure 3-4: Alcona County Recreation



## ***Recreation Outside of Alcona County***

In addition to recreation within Alcona County, city residents have access to recreational opportunities in Alpena, 32 miles to the north, as well as Oscoda, 16 miles south. The City of Alpena is the largest city in the northeast Michigan region and offers 22 recreational properties. Community based recreation in Alpena includes Plaza Pool at Alpena High School and many community parks with swimming and fishing access.

Oscoda High School has an indoor swimming pool which is open for public use on a limited basis; the community also has a waterfront park on its Lake Huron beach with playground equipment and tennis courts.

A second lake-side park area, located just north of Oscoda on U.S-23, offers picnicking and swimming. Several campgrounds are located in or near the Huron National Forest, including the Old Orchard Campground on the Au Sable River. The Lumberman's Monument area on the River Road offers a visitor's center with informative and educational displays depicting lumbering days, a gift shop, interpretive center, the impressive monument itself, numerous scenic hiking and walking trails, and a spectacular view of the Au Sable River. Picnicking and boating is also available at Van Etten Lake in Oscoda.

It is important to note that, while all of these regional recreational opportunities are available to residents of Alcona Township, many require fees and all require travel in order to access them.

# Chapter 4

## Planning & Public Input Process

---

### Alcona Township Planning Process

Development of a community recreation plan must involve interaction and input from citizens and community groups. The Alcona Township Board was the lead entity in developing the Township Recreation Plan. The Township Board sought input from the Alcona Township Planning Commission. Planning Commission and Township Board meetings were open to the public with time allocated for comments. A timeline for the development of the recreation plan update is as follows:

#### SCHEDULE

<b>June 10, 2015</b>	Township Officials contact Northeast Michigan Council of Governments (NEMCOG) requesting collaboration in drafting a recreation plan for Alcona Township.
<b>June 2015</b>	Northeast Michigan Council of Governments reviewed expiring plan and made corrections with information publicly available.
<b>July 9, 2015</b>	NEMCOG staff conducted site visits to Township owned properties to assess accessibility and gather photos.
<b>July 10, 2015</b>	A draft plan is sent to Alcona Township officials for review and comment.
<b>September 8, 2015</b>	Alcona Township Planning Commission held a public input session for the Recreation Plan.
<b>October 1, 2015</b>	Alcona Township Planning Commission met to clarify the plan and to further prioritize projects NEMCOG staff suggested partnering with other local units of government that are also updating their recreation plans to conduct a survey to gather more public input. Commission also made changes to the recreation plan to transmit to NEMCOG.

- October 13, 2015** Joint online recreation survey was posted to the following websites: Alcona County, Alcona Township, Caledonia Township, NEMCOG, US 23 Heritage Route and was shared via social media. Survey included sites in Alcona County, Alcona Township, Caledonia Township, and Harrisville Township. In addition, a link to the survey was provided in the Alcona Review and on True North Radio Network.
- October 31, 2015** The online survey was closed. 54 responses were transmitted to Planning Commission.
- November 5, 2015** The Planning Commission met and made further changes to the action table based on survey responses.
- December 5, 2015** The Planning Commission met and made minor changes to the recreation plan. The Planning Commission voted to put the plan out for the 30-day review period.
- February 3, 2016** A notice appeared in the Alcona Review advertising the public hearing scheduled for February 11, 2016.
- February 11, 2016** The Planning Commission held a public hearing on the Recreation Plan. The Planning Commission passed a Resolution of Adoption.
- February 16, 2016** The Township Board passed a Resolution of Adoption.

## **Public Input**

Citizen opinion on recreation priorities is key to the development of a recreation plan. Throughout the development of this recreation plan, members of key groups in Alcona Township were involved. Due to the small size of the community, the Planning Committee opted to hold a public input session to gather comprehensive public opinion and ideas about the future of parks and recreation in Alcona Township. The public was notified of the meeting through press releases and notices posted in area businesses as well as by word of mouth. In addition, an online survey was provided for citizens to provide input about recreational facilities. Alcona Township partnered with Alcona County, Caledonia Township, and Harrisville Township to create and publicize the survey. 54 people responded to the survey. The survey results can be found in Appendix A at the end of this plan.

Because of the small size of Alcona Township, the Planning Commission felt that the community was well-represented throughout the process especially in the online survey. After all public

input was gathered and recorded, the Planning Commission met to prioritize projects for the Action Plan and to develop a capital improvements plan.



## Public Input Session Minutes

### Alcona Township Planning Commission Recreation Plan Public Hearing Meeting Minutes September 8, 2015

The meeting was called to order by Marlena MacNeill at 7:00 PM.

The roll call included all members present from the Planning Commission: Doug Kuffert Chairman, Dave Dionne Vice-Chair, Tammy Hurt-Mendyka, Jack Bare, and Jim Mead. Also included were Marlena MacNeill Supervisor, Jim Bouchard Trustee and Citizen Don McKay.

Doug said he had received one e-mail from Carol Zurawka that asked if we would maintain the tennis court as it does get used regularly. It needs to be marked and a new net. Jim said that LLWC has a rubberized surface on their tennis courts and it requires a lot of maintenance.

Jack said his biggest concern is maintaining the facilities and Oscoda has a pristine beach. We should for a Sub-Committee that could go down there and research what they do to maintain their beach and park area. It may be wise for the Recreation Plan to include management.

Our main focus has been on Black River being developed so that it supplies more access to Lake Huron for Recreation. We are currently experiencing high water levels. There is a tidal pool forming.

Brush needs to be removed from both areas and the lawn taken better care of. Discussion on removal of pit toilets and replaced with porta pots. To have flush toilets and running water would require filling an area because of the wet conditions also a well & septic system.

There is such a need to maintain what we have that includes cutting dead trees and mowing just to keep a well-kept appearance before considering additional amenities because those things too will require maintenance. Can we get money in the budget to hire maintenance? There are funds currently being spent for mowing, trimming, and dredging. The Bridge Walk and a ball game that has brought in funds.

Black River/Lake Huron is being used regularly for swimming, picnicking, boating, fishing and biking. It was brought up that there used to be an ice rink...on the pond or by flooding a low area.

Fishing has changed along with the types of fish that are available.

We need to look at our timeline to determine what has to be done yet and have the highlighted areas of the Draft Recreation Plan changed to reflect our needs. We should also adjust some of the costs to be in line with today's costs.

Since we didn't get much input, it would be advisable for us to go over the plan individually and then have another meeting prior to the November meeting so we can move this along. Doug is tentatively setting the meeting for October 1, 2015 at 7:00 PM.

# Chapter 5

## Goals, Objectives, and Action Plan

---

**Goals & Objectives:** Goals and objectives were developed from public input session as well as by input from the Planning Commission.

1. To protect, promote and preserve the area.
2. To develop kayak/canoe shipwreck trail in close proximity to the Black River/Lake Huron Property, highlighting the shipwrecks in the Thunder Bay National Marine Sanctuary.
3. To develop and maintain strong local government involvement in recreational and tourism planning and projects.
4. To actively expand and improve upon the recreational needs of the community.
5. Provide a balance of recreational amenities which are oriented to the aging population to increase the desirability of the community to retirees.
6. Provide recreational amenities which are oriented toward the younger population and families in order to increase the livability of the community to attract young families to the area and retain older youth.
7. Support cooperative regional recreation planning and development with Alcona County, the Michigan DNR, and other surrounding communities.
8. Improve the quality of life for residents and bring visitors to Alcona Township by maintaining, improving and expanding recreation within the Township and surrounding areas by working cooperatively with local and State governmental agencies, community service agencies, and local businesses.
9. To encourage tourism as an economic resource for the community, yet recognize the need to provide other recreational opportunities to the residents.
10. Improve the overall local economy by enhancing the livability of the community in order to attract entrepreneurs and encouraging the creation of new tourism-based jobs.
11. To provide outdoor recreational facilities for the enjoyment of local residents, sports enthusiasts and visitors to Alcona Township; specifically:

## Black River/ Lake Huron Property

**Goal:** Enhance the recreational opportunities at the Black River/Lake Huron property to encourage its establishment as a primary recreational facility in the Township.

1. **Objective:** Provide amenities to improve the overall usability of the park.

- a) **Action:** Improve signage to and within the park.
- b) **Action:** Remove of dead trees and improved landscaping.
- c) **Action:** Install kayak/canoe launch dock in Black River.
- d) **Action:** Work with Alpena Shipwreck Tours and the Thunder Bay National Marine Sanctuary to develop a kayak/canoe shipwreck trail within close proximity of the property.
- e) **Action:** Install rip rap at the mouth of the river.
- f) **Action:** Improve site lighting.
- g) **Action:** Improve parking and driveways.
- h) **Action:** Add picnic tables, grills and additional playground equipment.
- i) **Action:** Install a volleyball court.
- j) **Action:** Improve boat launch facilities.
- k) **Action:** Construct of a concrete pier extending 300' to 400' into the lake on the north side of Black River.
- l) **Action:** Upgrade entire site to ADA specifications.
- m) **Action:** Construct additional pavilion/addition to existing pavilion to create more picnicking opportunities during busy periods or less than ideal weather conditions.

## Hubbard Lake Eastshore Property

**Goal:** Enhance the recreational opportunities at the Black River/Lake Huron property to encourage its establishment as a primary recreational facility in the Township.

1. **Objective:** Provide amenities to improve the overall usability of the park.

- a) **Action:** Seeding and landscaping.
- b) **Action:** Develop the 53' x 200' site by adding a picnic area with picnic tables and grills.

2. **Objective:** Stop deterioration of property.

- a) **Action:** Stabilize shoreline from erosion.
- b) **Action:** Limit winter traffic accessing lake to ATV and snowmobiles by providing only a narrow access point, not passable by vehicular traffic.

## Black River Recreation Area

**Goal:** Enhance the recreational opportunities at the Black River Recreation Area to encourage its establishment as a primary recreational facility in the Township.

1. **Objective:** Provide amenities to improve the overall usability of the park.

- a) **Action:** Construct pavilion for picnics and patrons using playground equipment.
- b) **Action:** Add picnic tables, grills and additional playground equipment.
- c) **Action:** Paint boundary lines on tennis court and basketball court.
- d) **Action:** Replace nets on tennis court and basketball hoops with suitable material.
- e) **Action:** Mend fencing on baseball field.
- f) **Action:** Improve pit toilets.
- g) **Action:** Landscape improvement and removal of brush and dead trees.

## Township Hall

**Goal:** Enhance the recreational opportunities at the Alcona Township Hall to encourage

its establishment as a primary recreational facility in the Township.

1. **Objective:** Provide amenities to improve the overall usability of the property.

a) **Action:** Add Picnic tables and playground equipment such as swings and a slide.

b) **Action:** Construct pavilion and add grills.

c) **Action:** Install basketball hoop at far end of parking lot, utilizing paved area.

### **Basis for Action Program**

There are a number of issues to consider when planning for recreational facilities in Alcona Township:

1. The median age of residents in Alcona Township is 63.4 years old, compared to the state's median age of 39.1. With a higher median age comes a high percentage of wheelchair use. All of the recreational facilities in Alcona Township lack universal accessibility and are in need of improvements.
2. Young people ages 0-19 comprise 13% of the Township population and 23% of the population is between 20-54 years of age. Recreational facilities in the Township need to appeal to a very diverse age group.
3. Residents of retirement age (65 +) comprise 46% of the Township population. Thought must be given to planning for this large resident population which has both the time and desire for age-appropriate recreational activities.
4. Alcona Township's median household income is \$45,703 compared to that of the state average of \$48,411. Nearly 66% of the households in the township include Social Security recipients, compared to 32.3% statewide. Nearly fifty-two percent of households have retirement income, compared to 22.7% statewide. Accordingly, to truly be accessible, recreation must also be affordable which means that nearby facilities should be enhanced to lessen the driving time and expenses that residents would incur to travel to facilities farther away.
5. Alcona Township is very proud of its natural beauty and rural character. It is important to those planning for its growth and development that every effort be made to balance ecological concerns with tourism potential. Protection of natural resources and scenic areas must therefore be a major element of the planning process.
6. The issue of improving the local economy by establishing the area as a recreation destination is of utmost importance. Unemployment rates in Alcona Township are reported at 10.1% (2014), and all of Northeast Michigan remained significantly higher than the state average. The Township strives to create a community with a defined sense of place and a

high quality of life which will attract young families and entrepreneurs. This quality of life will also help to retain local youth who otherwise would leave the area upon reaching adulthood. The retention of youth and attraction of visitors are two methods with which the Township hopes to continue its economic turn-around.

With these issues in mind, other factors to be considered in recreational plan development for Alcona Township include:

1. Development of recreation opportunities which are appropriate to the Township's major population groups. Both active and passive recreation opportunities require easy access to allow use by those with limited transportation resources, including the elderly and youth of the Township.
2. Development and maintenance of recreational opportunities for individuals with diverse incomes, including recreation available at a no-cost or low-cost basis, as well as appealing to upscale, urban visitors.
3. Maintenance and operation of existing and new recreational facilities in a manner that preserve their ecological and scenic value, with limited staff.

## Capital Improvement Plan

The Capital Improvement Schedule found below describes what recreational improvements the parks and recreation committee as well as the Township would like to pursue over the next five years.




